Who is looking after this website?

What information is collected?

Information is collected from you when you place an order or fill out a form.

When ordering or registering on the site, as appropriate, you may be asked to enter your name, e-mail address, mailing address or phone number. You may, however, visit the site anonymously.

What is your information used for?

Any of the information collected from you may be used in one of the following ways:

- To present feedback/reviews on products if you have given your permission.
- To process transactions. Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the purchased product or service requested.
- The email address you provide for order processing will only be used to send you information and updates pertaining to your order.

How is your information protected?

A variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

Online payments are made using PayPal. All sensitive/credit information is transmitted via PayPal and is inaccessible from managers of this site. Your private information (credit cards, social security numbers, financials, etc.) is not stored or submitted on our servers.

Telephone orders?

For telephone orders details are taken only for the purposes of the credit card machine transaction being made at the time of the order. A customer copy of the receipt for any credit card orders made by telephone will be included with the package of goods on delivery. It will be sent by post to the purchaser if the purchaser's address is different to the delivery address.

Are cookies used?

Google analytics are being used on this website to provide information on referring websites and the most visited pages.

Is any information disclosed to outside parties?

21st Century Renaissance and The Visual Time Traveller does not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties (e.g. PayPal) who assist in operating the websites, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. Your information may only be released when it is believed that release is appropriate to comply with the law, enforce the site policies, or protect ours or others rights, property, or safety.
